Ashiya city was originally planned to be constructed in all directions from the south side of JR Ashiya Station, with environmental facilities and amusement facilities in the surrounding area. Along the Ashiya beach, you can see an aquarium, brine baths, swimming pool, club houses and a yacht harbor. There was a plan to connect Shiroyama and Rock Garden by a ropeway, which shows the grand development of the city.

In 1951, the "International Cultural and Residential City Construction Act was issued and urban development has been proceeding at full swing ever since.

A State of Emergency Declared!

A state of emergency has been declared. Please do not go out unnecessarily. Let's overcome this crisis by uniting together to protect our own lives and the lives of our loved ones, and also to prevent the collapse of the medical system.

International Cultural and Residential City, Ashiya - 70 Years of Progress

This year marks the 70th anniversary of the enactment of the "Ashiya International Cultural and Residential City Act" During the decade from 1945, when postwar reconstruction was still in progress, our predecessors envisioned Ashiya of the future.

<Birth of Ashiya>

On March 3, 1951, the "Ashiya International Cultural and Residential City Act" was passed as a special law for Ashiya City. This proclamation was the start of Ashiya City's message to the whole country that it would develop into a superb residential city. During the war, 40 % of the city was lost in air raids. Ashiya City was in chronic financial difficulties because of the larger amount of money needed for reconstruction. Under such circumstances, this special Act was passed in order to rebuild the city quickly with the help of the government, and promote it as an excellent residential city.

Article 1 reads as follows:

Ashiya, which has a blessed environment and excellent location as a residential area, will be constructed as an international cultural residential city suitable for foreign residents, with the aim of attracting and settling foreign visitors, improving international culture and reviving the economy.

This shows our determination to create a wonderful city that we can be proud of abroad. There are only 14 cities within Japan, including Ashiya, where this law has been enacted.

<Holding a referendum>

In December 1950, the year Ashiya City celebrated its 10th anniversary as a city, the Ashiya International Cultural and Residential City Act was passed in the 9th extraordinary Diet session. However, since this special law applied only to Ashiya City, it was necessary to obtain the approval of a majority of the residents in a referendum, which was held on February 11, 1951. A newspaper describes the situation:

Today is the referendum- Ashiya, eager to prevent abstention

From 7:00 a.m. on the morning of the referendum, the city sounded sirens at the city hall and the Uchide Community Learning Center (right) every hour to raise interest in the referendum. All the elementary and junior high school students participated in a megaphone campaign to "Make sure you vote!" and the Boy Scouts and children's associations called out, "Don't abstain from voting."

We can see how Ashiya City actively encouraged the citizens to vote. The day before the vote, the newspaper carried a comment by Tomita Saika, a poet:

"Think carefully before voting", Mr. Tomita says

We are receiving a number of microphones messages and leaflets for and against, and the citizens are confused as to which is right. It seems that there is a lack of seriousness in all this propaganda. Wouldn't it be better to be frank and say clearly that we cannot develop our city without this Act? I hope that voters will make a calm decision and vote without being pulled in different directions by various propaganda and messaging.

Excerpt from the Asahi Shimbun, February 10, 1951

The result of the referendum was 77.6% in favor. (10,288 in favor, 2,949 against, 163 invalid, voter turnout, 56%). That night, Mayor Sarumaru talked about the future plans and aspirations of Ashiya City.

Once the Act is enacted, I will do my best to create a utopia by working together with all citizens to keep the spirit of the law. I'm looking forward to seeing what Ashiya City will look like in 20 years.

<Pro Baseball Open Game>



In commemoration of the passing of the Act, an open professional game took place. Hankyu (the present Orix Buffaloes) vs Tokyu (the present Nippon Ham Fighters) was held at the former Kobe Bank Ground (Matsuhama-cho 14) in Ashiya in March 1951. The majority of 3,000 spectators were juvenile fans, but there were also ladies with dogs in the crowd.

<Ashiya's Future depicted in "8 cities of Tourism Culture">

On April 15, 1952, the International Special City Construction League was formed made up of 8 cities (now 11 cities) that had passed the Special City Construction Act. Ashiya's future was described as being a green city with parks, improved transportation networks, a complete water sewage system, libraries, museums, etc. It concluded with the following statement:

We believe that this project will not only contribute to the local industry, economy and culture domestically, but also to the modern tourism and international cultural and economic exchange externally.

We must continue our efforts to enhance and develop this vision and create a city that we can look forward to 20 years from now.

Landscape of International Cultural Residential City (Abridged)

Ashiya is a small town surrounded by mountains and the sea. Its development began before the World War II as a residential city full of greenery and light. A unique lifestyle called Hanshin Modernism was born here. This image as an excellent residential environment was incorporated into

the postwar urban development. The "Ashiya International Cultural City Construction Act" (1951) which was backed by a referendum, aims to create a residential city full of international spirit and culture. It can be regarded as an example of how to develop an autonomous sustainable city protecting and nurturing a small but high-quality living environment.

The cityscape is an expression of people's lives. The richness of the greenery is the richness of gardens, and the gentle-mannered way of life compliments the calm streetscape. In the middle of developing this landscapes, the Great Hanshin-Awaji Earthquake struck the city. Many memorable landscapes were lost and once efforts were made to revive Ashiya's unique appeal.

Once more, the "Ashiya International Cultural Residential City Act" will help us reconfirm the way of life that was chosen by Ashiya residents, one which aims to create a landscape that nurtures rather than consumes the environment.

Change brings dynamism to the city, and the living landscape changes with the times. Signs of change in the way we work are developing as we deal with the Coronavirus crisis. In the future, the appeal of a residential city will also mean a choice of places to work.

Ashiya is the only one of the 14 cities which enacted the postwar "construction law" that aims to become a residential city, a city that does not pursue quantitative expansion but seeks qualitative sustainability.

Power Stones, designated as the cultural asset by Ashiya City

Chikara-ishi, are stones that were used to test the strength of men in the precinct of Abo Tenjinja Shrine and they have been designated a cultural asset by Ashiya City. Power stones were used in rites of passage for men in rural areas as a test of strength. Six Abo Tenjinja Shrine power stones are still in existence in the precinct, two of which are inscribed with the characters: 50 kan (187.5 kg) and 42 kan (157.5kg). I kan =3.75kg

Peace of Mind in Ashiya; Supporting Child-rearing

On April 1, "Nishikura Municipal Kodomo-en", which is a merger of "Niihama Municipal Child Daycare Center" and "Ise Municipal Kindergarten" opened, and "Seido Municipal Kodomo-en" got a new start with moving into the new building.

The children were really looking forward to going to the Kodomo-en and on the first day when they saw the shiny new buildings they were so happy, shouting out, "Oh, it's so beautiful!" Cherishing the expectation of children, we would like to make the Kodomo-en a happy, fun place for them to be. Furthermore, we will be offering the following two new services.

Temporary Custody Service (Inside Nishikura Municipal Kodomo-en)

We will look after children for those who are temporarily unable to take car e of them at home owing to school attendance, working, etc.

- Operation Hours: 9:00 a.m.-5:00 p.m. Weekdays (Closed on Sat., Sun., public holiday, the New Year's holiday and closing days of Kodomo-en)
- Eligibility: A preschool child, over 1 year old, who lives in Ashiya and corresponds to any of the following: (* Usage limited to a max of 12 days a month)
 - A child whose guardian has difficulty providing childcare at home owing to working, school attendance, etc.
 - ▶ A child whose guardian has temporary difficulty providing childcare at home owing to unavoidable reasons such as disease, childbirth, nursing care, etc.
- Cost: 2,500 yen per day (including 500 yen for school lunch)

Care Service for Sick/Convalescent Children (Inside Seido Municipal Kodomo-en)

We will look after children when they are unable to attend their regular childcare/educational facility owing to illness or injury.



- Operation Hours: 7:30 a.m. 6:00 p.m. Weekdays
 (Closed on Sat., Sun., public holiday, the New
 Year's holiday and closing days of Kodomo-en)
- Eligibility: A child who lives in Ashiya and corresponds to all of the following (6 months of age or older and up to the 6th grade of elementary school)
 - ► A child whose guardian has difficulty providing care at home owing to work, injury/illness, etc.
 - ► A child who has not completely recovered from illness or injury but is convalescing in a stable condition.
- * If the child has measles, influenza, is unable to take water or food, or is possibly infected with COVID-19, this service cannot be used.
- Cost: 2,500 yen per day (including 500 yen for school meal)



Under A Third State of Emergency

A third state of emergency was declared on April 25 for Hyogo Prefecture amid rising COVID-19 infections, and it will be effective until May 11. To effectively contain the spread of the virus, we have to curb the flow of people. It is important that each member of the public is mindful of the situation and takes responsibility to protect all our lives. Please practice the four emergency measures.



- Refrain from unnecessary outings and going outside for purposes other than those necessary for daily living.
- Avoid visits to drinking and eating establishments outside the new shortened business hours.
- Refrain from nonessential travel to other prefectures or areas with higher risks of infection. (e.g., visiting one's home town)
- Refrain from participating in events, etc.

Re-issuance of Housing Security Benefits

Partnership Oath System

Moving-in and moving-out procedures will be simplified for individuals certified under the Partnership Oath System when they move between the municipalities listed below. These municipalities have entered into a cooperation agreement.

Ashiya City strives to make its Partnership Oath System more accessible by simplifying its requirements.

■ Cooperation Agreement Among Municipalities:

Seven cities and 1 town which have a Partnership Oath System have entered into a cooperation agreement – Amagasaki City, Nishinomiya City, Ashiya City, Itami City, Takarazuka City, Kawanishi City, Sanda City, and Inagawa Town.

- Changes to the Eligibility Requirements under the Partnership Oath System:
- ➤ Both partners are citizens of or plan to reside in Ashiya City.

 <u>Either one or both</u>

 <u>partners</u> are citizens of or plan to reside in Ashiya City.
- ➤ The partners are not close relatives to one another. If the partners are related by adoption, they may pledge an oath after their adoptive relationship is dissolved.

Total Exemption from Light Vehicle Tax (Category Base)

People with disabilities are exempt from light vehicle tax (category base) or automobile tax (category base) for one vehicle.

- Eligibility: A light vehicle which is owned by someone who is registered disabled, or by a person who shares a home and livelihood with the disabled person, and corresponds to any of the following criteria:
 - The disabled person drives the light vehicle themselves.
 - The person who shares the livelihood with the disabled person drives the light vehicle for the disabled person.
 - A person who constantly cares for a household which consists of the disabled only drives the light vehicle for the household.

Residents should conduct operational testing of fire alarms and smoke detectors periodically to ensure that they work properly. Alarms and detectors should be replaced every 10 years or so.




